1 Scope of application:

The provisions set out in the delivery conditions regulate the smooth logistical process between ANDREAS STIHL AG & Co. KG (hereinafter referred to as STIHL) and its suppliers.

2 Delivery adresses

The postal delivery address specified by STIHL on orders, delivery schedules, subcontracts, etc. must be strictly adhered to. The supplier will be invoiced for any consequential costs arising from non-compliance.

3 Delivery times:

Incoming goods at all STIHL plants as well as DSV and Munz are ready for receipt from Monday to Friday as listed above.

Minor deviations in the various STIHL plants are possible. These must be requested individually before delivery.

4 Shipping documents:

Each delivery must be accompanied by a delivery bill in duplicate. Deliveries for which the ISPM 15 standard has been agreed must be accompanied by written proof on the commercial invoice or an additional certificate regarding the handling of the prescribed and used wooden pallets must be handed over to the incoming good department of the respective delivery address before the goods are unloaded.

Each packaging unit (e.g. crate) must also be accompanied by a packing slip.

Each delivery bill must contain the following information:

- Supplier number, name
- recipient
- STIHL delivery schedule number(s) plus item number(s) for the delivery schedule, if applicable, subcontract number and order number
- STIHL material numbers and STIHL part designation at item level
- Delivery date
- Number of items, quantity
- Means of transportation / container
- Weight (gross, net)

5 Delivery packaging

6 Goods receipt

On arrival of the goods, the carrier / truck driver must report immediately to the STIHL employee responsible. The goods will be unloaded by STIHL specialist personnel. Joint unloading is possible in special cases with prior agreement.

In D4, the forwarders always unload the goods themselves at the ramps; large containers are unloaded by the logistics company.

7 Load securing / minimum requirement transport vehicle

Shipments will only be accepted if the deliverer complies with all applicable laws and other regulations. These are in particular:

- Road Traffic Regulations § 22 Loading, § 23 Other obligations of the driver of the vehicle
- Commercial Code §§ 412 Loading and unloading
- BGV D29 Vehicles
- VDI Guideline 2700 Load securing on road vehicles
- CTU packing guidelines
- UVV
- DIN-standards
- ADSp
- GÜKBIIIBG
- ADR, GGVSE
- other legal regulations for transportation by road, if applicable.

The supplier undertakes to point out these statutory provisions to the forwarding agents / service providers commissioned by him. At this point, STIHL draws particular attention to the securing of the goods on the truck and the wearing of protective footwear and a safety vest by the truck driver.

Deliveries with vans are only possible to a limited extent and must be agreed in advance.

The forwarding agent must ensure that the goods for STIHL are always loaded at the rear so that no third-party goods have to be moved when unloading the goods.
